TO MEASURES OF GOVERNMENT SUPPORT FOR BUSINESS IN LENINGRAD REGION

INTRODUCTION

According to the results of 2016 Leningrad region has entered top-15 of the most economically active regions in Russia, has occupied the 11th place among all subjects of the Russian Federation in terms of economic growth rates and has entered top-20 of the National Rating of Investment Climate in the Regions according to the Agency for Strategic Initiatives. It is mainly connected with creation of the efficient mechanism of government support for industry, business and agro-industrial complex in the region.

Over 9.3 billion rubles –

the volume of direct financial support provided by Leningrad region to organizations in 2016

Leningrad region is open for investments and grants various measures of support for organizations. In 2016 the region provided reduced tax rates and measures of direct financial support amounted to more than 9.3 billion rubles.

Industrial enterprises of Leningrad region actively use federal measures of government support with assistance of the region: soft loans and leasing programmes of the Industrial Development Fund and targeted subsidies for priority directions of civil industry provided by the Ministry of Industry and Trade of the Russian Federation. In 2016 about 3 billion rubles from the federal budget were attracted to the economy of Leningrad region.

Government support of industrial enterprises allowed modernizing production, exploring promising innovative technologies, improving quality and competitiveness of produced goods, creating new high paying jobs in the region.

Socio-Economic Development Strategy of Leningrad Region up to 2030 involves further development of the economy, entrance of the region in top-10 of Russian regions in terms of the volume of industrial production. Improvement of the mechanisms of government support for enterprises, small and medium-sized businesses will contribute to successful achievement of goals defined in the Strategy.

This brochure is a guide for investors and heads of enterprises, small and medium-sized businesses, agricultural organizations to measures of support provided at the regional and the federal level.

FRONT OFFICE FOR INVESTOR RELATIONS OF THE ADMINISTRATION OF LENINGRAD REGION

To ensure maximum support of the business and provide assistance to investors in the region, the Front Office for Investor Relations of the Administration of Leningrad Region was established under the auspices of **Economic Development Agency of Leningrad Region**.

PROJECT SUPPORT

The following types of support are available for investment projects implemented in Leningrad region:



Information and advisory assistance for the investor

The investor is provided with information about:

- federal and regional support measures
- the list of industrial sites
- the extent to which the engineering, transport and social infrastructure is developed in certain territories
- the procedure for obtaining technical specifications and entering into contracts for utility connection
- tariff and tax rates
- the talent pool
- the list of documents required to implement a project, the timing, procedure and place of obtaining approvals and permits
- other information related to implementation of investment projects in Leningrad region



Selection of the investment site

Made at the investor's request on the basis of the data provided in the application for support, including:

- information about the investment site is provided to the investor within 3 working days
- in the absence of investment sites meeting all criteria stated in the application, the investor is provided with the information about the investment sites most closely meeting the declared criteria
- after the investor has considered investment site options, the Front Office will agree the investor's visits to the relevant sites with their owners/tenants so that the investor could make the final decision



Support during the procedure of connecting to the engineering and transport infrastructure

Provided by means of analyzing the reasonableness of fees (tariffs, payments) at the investor's request, including:

 the reasonableness of fees (tariffs, payments) related to engineering and transport support of the investment site is analyzed if the corresponding fee (tariff, payment) is regulated by the Government of Leningrad Region



CONDITIONS FOR PROVISION OF GOVERNMENT SUPPORT

- registration for tax purposes in Leningrad region
- completion of an investment project with investments in fixed assets not less than 300 million rubles (not less than 50 million rubles for Boksitogorsky, Lodeynopolsky and Podporozhsky districts of Leningrad region)
- non-use of the scheme of processing of customer-owned raw materials
- economic activity within the stimulated OKVED codes determined in the law, with the revenue within these codes not less than 70% of the total revenue of an organization

- a business plan of an investment project which includes information about the main production and financial indices of the project

- (5) a letter of guarantee on compliance with the law
- (6) copies of draft contract signed by an investor

TAX BENEFITS FOR THE SUBJECTS OF TRADING ACTIVITY

Regional law of 08.04.2002 No. 10-oz On Measures of Government Support for Trading Activity in Leningrad Region.



BASIC TERMS OF TRADING ACTIVITY

Traders — business entities with the revenue from trading activity not less than 90% of the total revenue.

Trading activity — measures on the wholesale trade of certain types of goods.

Certain types of goods — goods not produced in Leningrad region (and) or goods included in the list approved by the Government of Leningrad Region (Resolution of the Government of Leningrad Region of 05.09.2002 No. 158).

AMOUNT OF SUBSIDIES

(depends on the amount of the corporate profit tax transferred to the regional budget of Leningrad region and annual monthly amount of the tax base of corporate profit tax)

up to 10 million rubles	10% of the tax amount deducted to the budget of Leningrad region

MEASURES OF DIRECT FINANCIAL SUPPORT FOR INDUSTRY

Subsidies are granted according to the **subprogramme Development of Industry and Innovations in Leningrad Region** of the government program of Leningrad region Stimulation of Economic Activity of Leningrad Region.

Subsidies are granted provided that a subsidy recipient and the Committee for Economic Development and Investment Activity of Leningrad Region **conclude an agreement** on provision of a subsidy.

MAIN CONDITIONS FOR GRANTING SUBSIDIES

- there should be no bankruptcy proceedings, reorganization, liquidation, suspension of activity
- there should be no salary arrears
- there should be no tax arrears and arrears on return of payments to the budget
- wage of employees of an enterprise should not be less than it is determined in the regional agreement on minimum wage in Leningrad region*
- a subsidy recipient should not be a foreign legal entity and participation of legal entities registered in a state not providing information about financial operations in the recipient's authorized capital should not exceed 50%
- timely provision of documents for subsidies

BASIC DOCUMENTS FOR GRANTING SUBSIDIES

- an extract from the Unified State Register of Legal Entities; additionally an extract from the register of shareholders is provided (for public joint-stock companies and joint-stock companies)
- a certificate of absence of the reorganization, liquidation proceedings, absence of arbitration award on recognition of bankruptcy and opening of bankruptcy proceedings
- a certificate of non-reinstatement of activities of a legal entity given by the territorial department of bailiffs of the Federal Bailiffs Service in Leningrad Region
- a certificate of absence of overdue debts on return of subsidies, budget investments and other overdue debts to the appropriate budget of the Russian Federation
- a certificate given by a territorial tax authority of Leningrad region and certificates given by state extra-budgetary funds of the Russian Federation on absence of overdue debts on payment of taxes, fees, insurance fees and other compulsory payments to the budgets of the Russian Federation
- 6 a certificate of average monthly salary of employees
- (7) a certificate of absence of salary arrears
- 8 a certificate which includes bank details and bank account to transfer a subsidy

All documents should be issued **not more** than **30** days before the day when an application for a subsidy is submitted.

SUBSIDIES RECIPIENTS

Legal entities registered for tax purposes in Leningrad region and carrying out economic activity in accordance with code 29.10.2 "Production of Cars". section C "Manufacturing" of the Russian National Classifier of Economic Activities (OKVED).



SUBSIDIES RATES

The subsidies cover actual costs incurred from 1 January to 30 September of the current year on transportation of employees and on professional training, retraining and advanced professional training of personnel.





ADDITIONAL DOCUMENTS FOR GRANTING SUBSIDIES

- · a certificate of absence of any subsidies received from the federal budget, the regional budget of Leningrad region and a local budget on reimbursement of actual costs incurred on transportation of employees and on professional training, retraining and advanced professional training of personnel
- · a certificate confirming that the revenue from activity according to 29.10.2 OKVED code is not less than 70% of the total revenue from sales of products (goods, works, services)



- copies of contracts with transport organizations on provision of services on transportation of employees
- copies of documents confirming payment of services on transportation of employees

Subsidy for reimbursement of expenses on professional training, retraining and advanced professional training of personnel:

- copies of contracts with an educational organization on provision of educational services on professional training, retraining and advanced professional training of personnel
- copies of licenses of educational organizations confirming their right to carry out educational activity
- copies of payment documents confirming actual costs incurred on professional training, retraining and advanced professional training of personnel

- copies of acceptance certificates on professional training, retraining and advanced professional training of personnel
- a certificate confirming employment of personnel before and after professional training, retraining and advanced professional training
- copies of standard documents confirming completion of professional training, retraining and advanced professional training by an employee

SUBSIDIES RECIPIENTS

Legal entities registered for tax purposes in Leningrad region and carrying out economic activity in accordance with subsection 29 "Production of Motor Vehicles, Trailers and Semi-Trailers", section C "Manufacturing" of the Russian National Classifier of Economic Activities (OKVED).



SUBSIDIES RATES

The subsidy covers 75% of costs on testing materials, produced components and (or) technical equipment, excluding VAT.



ADDITIONAL DOCUMENTS FOR GRANTING SUBSIDIES

- a certificate of absence of any subsidies received from the federal budget, the regional budget of Leningrad region and a local budget on reimbursement of expenses on testing materials, produced components and (or) technical equipment
- copies of documents confirming the fact that the appropriate work (services) has been conducted
- copies of contracts according to which expenditures on testing materials, produced components and (or) technical equipment have been incurred
- copies of payment documents confirming payment of actual costs incurred on testing materials, produced components and (or) technical equipment

SUBSIDIES TO LEGAL ENTITIES OPERATING IN LENINGRAD REGION FOR PARTIAL REIMBURSEMENT OF INTEREST RATE FOR LOANS ATTRACTED BY LIGHT INDUSTRY ENTERPRISES

Resolution of the Government of Leningrad Region of 30.05.2017 No. 187.



SUBSIDIES RECIPIENTS

Legal entities registered for tax purposes in Leningrad region and carrying out economic activity in accordance with subsection 13 "Manufacture of Textile Products", subsection 14 "Manufacture of Wearing Apparel", subsection 15 "Manufacture of Leather and Leather Products", section C "Manufacturing" of the Russian National Classifier of Economic Activities (OKVED) which concluded a contract with Russian credit organizations on provision of loans in the currency of the Russian Federation aimed at expansion and modernization of production, acquisition of materials and supplies.



SUBSIDIES RATES

The subsidies are granted once a year and cover actual claimed and documented costs on payment of interest rate charged from 1 January to 30 September of the current fiscal year for loans received in Russian credit organizations, but not more than 0.75 of the key rate of the Central Bank of the Russian Federation in case the interest rate for loan is higher than or equal to the key rate of the Central Bank of the Russian Federation when the loan agreement is concluded.

In case the interest rate for loan is lower than the key rate of the Central Bank of the Russian Federation when the loan agreement is concluded the compensation is not more than 0.75 of the amount of expenses of the organization on payment of interest on loan.

Additional condition:

a legal entity did not break conditions of loan repayment and payment of interest stipulated by the loan agreement.







ADDITIONAL DOCUMENTS FOR GRANTING SUBSIDIES

- a certificate of absence of any subsidies received from the federal budget, the regional budget of Leningrad region and a local budget on partial reimbursement of actual claimed and documented costs on payment of interest on loan (or on tranches within credit lines) attracted for expansion and modernization of production, acquisition of materials and supplies
- an extract from a loan account confirming received loan and documents confirming timely payment of accrued interest on loan and timely repayment of a loan
- 3 a copy of a loan agreement

- a copy of a loan amortization schedule and an interest payment schedule
- 5 calculation of a subsidy granted from the regional budget of Leningrad region according to the approved form
- a report on execution of the loan agreement according to the approved form
- copies of documents confirming disbursement of funds under the loan agreement

MEASURES OF GOVERNMENT SUPPORT FOR INDUSTRIAL PARKS

A regional law of 28.07.2014 No. 52-oz On Creation and Development of Industrial Parks in Leningrad Region was adopted in Leningrad region in order to stimulate creation of industrial parks and implementation of infrastructural projects in the region.



GOVERNMENT SUPPORT RECIPIENTS

Management companies of industrial parks. A decision on granting industrial park status or on refusal to grant this status is made by the Government of Leningrad Region according to the **Resolution of the Government of Leningrad Region of 05.07.2016 No. 218**On Implementation of Certain Provisions of Regional Law of 28.07.2014 No. 52-oz On Creation and Development of Industrial Parks in Leningrad Region



BASIC DOCUMENTS FOR GRANTING INDUSTRIAL PARK STATUS

- Programme for creation and development of an industrial park prepared and approved by a management company
- an extract from a protocol of Interdepartmental Commission on Location of Production in Leningrad Region about approval of a location for placement of an industrial park
- an extract about inclusion of an industrial park in the List of Industrial Parks of the Ministry of Industry and Trade of the Russian Federation

Industrial park status is given **for an lindefinite period**. Together with the decision on granting industrial park status the Government of Leningrad Region makes a decision on **granting management company status**.

The residents of industrial parks receive measures of government support according to the **regional law of 29.12.2012 No. 113-oz** On Government Support for Organizations Undertaking Investment Activity in Leningrad Region and Amending Certain Legal Acts of Leningrad Region.

Land plots with buildings and constructions can be bought by owners of these buildings at a price of 15% of the cadastral value according to the **Resolution of the Government of Leningrad Region of 25.05.2015**No. 179 On Approval of the Procedure of Pricing for Sale of Land Plots Owned by Leningrad Region and Land Plots State Ownership on Which is not Delimited, Which are Provided without Tenders.

MINISTRY OF INDUSTRY AND TRADE OF THE RUSSIAN FEDERATION



INDUSTRIAL DEVELOPMENT FUND



The Ministry of Industry and Trade of the Russian Federation (Minpromtorg Russia) carries out functions on development of public policy and on normative legal regulation in the sphere of industrial complex and defense industry, development of aeronautical engineering, technical regulation and ensuring uniformity of measurements and functions on state regulation of foreign trade activity.

Industrial Development Fund (IDF) was established in 2014 at the initiative of the Ministry of Industry and Trade of the Russian Federation for modernization of the Russian industry, creation of new industry sectors and support for import substitution. The Fund offers preferential conditions for co-financing of projects aimed at the development of **new high-tech products**, modernization and creation of competitive production processes on the basis of the best available techniques.

The Russian Export Center is a joint-stock company established as a specialized organization, "one-stop-shop" for interaction with exporters.

MEASURES OF GOVERNMENT SUPPORT FOR SMALL AND MEDIUM-SIZED BUSINESSES

Subsidies are provided to small and medium-sized businesses within the subprogramme Development of Small, Medium-Sized Business and Consumer Market of Leningrad Region of the government programme Stimulation of Economic Activity of Leningrad Region on a competitive basis, on conditions that business concludes a contract with the Committee for Development of Small. Medium-Sized Business and Consumer Market of Leningrad Region.

MAIN CONDITIONS FOR GRANTING SUBSIDIES

- registration for tax purposes in Leningrad region
- absence of a liquidation or bankruptcy procedure on the day of applying for a subsidy
- absence of overdue arrears in payments to budgets of all levels of the budgetary system of the Russian Federation and state extrabudgetary funds on the day of submission of an application for participation in a competition
- availability of information on the subject of small and mediumsized business in the Unified Register of Small and Medium-Sized Businesses of the Federal Tax Service of Russia

- absence of arrears in payment of salary to employees on the day of application
- absence of unfulfilled obligations to the Committee for provision of information on economic activities in previous years
- wages of the entrepreneur's employees should not be less than it is established by the regional agreement on minimum wage in Leningrad region*



SUBSIDIES FOR ORGANIZATION OF BUSINESS ACTIVITY

Resolutions of the administrations of municipal districts and the city district of Leningrad region.

Reimbursement of up to 80% of expenses on organization of business activities and not more than 500 thousand rubles.



Reimbursement of not more than 70% of actually incurred expenses on payment of leasing payments in terms of the lessor's income, the maximum amount of compensation - 1 million rubles.

SUBSIDIES RECIPIENTS

Subjects of small and medium-sized businesses, the main activity of which is production of goods (reimbursement of expenses on equipment for the provision of services is not made).



SUBSIDIES RATES

Reimbursement of not more than 50% of the amount of expenses and not more than 5 million rubles.

Subjects of small and medium-sized businesses dealing with the accommodation of tourists.



SUBSIDIES RATES

Reimbursement of **not more than 80%** of actual expenses incurred. the maximum subsidy is 1 million rubles.



The subsidies are granted provided that a subsidy recipient and the Committee for Agro-Industrial and Fishery Complex/Veterinary Administration of Leningrad Region **conclude an agreement** on provision of a subsidy in the current year.

MAIN CONDITIONS FOR GRANTING SUBSIDIES

- there should be no tax or fees arrears or arrears on other obligatory payments to the budgets of the Russian Federation
- there should be no reorganization, liquidation, bankruptcy proceedings and restrictions on economic activity
- there should be no overdue (more than 3 months) wage arrears (except owners
 of personal household plots)
- there should be no overdue arrears on return to the relevant budget of the Russian Federation of subsidies, budget investments provided in accordance with other legal acts and other overdue arrears to the relevant budget of the Russian Federation
- recipients of subsidies should not receive funds from the relevant budget
 of the Russian Federation in accordance with other regulatory legal acts,
 municipal legal acts for the above mentioned purposes

















MAIN DOCUMENTS FOR GRANTING SUBSIDIES



a certificate with calculations for payment of subsidies according to the form approved by the order of the Veterinary Administration of Leningrad Region (for reorientation of households and animal disease control)/Committee for Agro-Industrial and Fishery Complex of Leningrad Region



certificates of absence of overdue debts on taxes and fees, on salary (except for the citizens managing personal household plots), a certificate from the Social Insurance Fund

PROCEDURE OF GRANTING SUBSIDIES



applications should be submitted within the period specified in the **Procedure for Granting Subsidies** from the Regional Budget of Leningrad Region for each subsidy





the decision about granting/refusal to grant a subsidy should be made **not later than 10 working days** from the date of receipt of the documents
